Memorandum of Understanding Between

MONO-CENTER FOR PROVISION OF SERVICES TO THE UNEMPLOYED POPULATION "ISHGA MARKHAMAT" UNDER THE MINISTRY OF EMPLOYMENT AND LABOR RELATIONS, Uzbekistan And

NANJING POLYTECHNIC INSTITUTE, CHINA

Signed on 26th June, 2019, in Tashkent, The Republic of Uzbekistan.

It is the desire of the parties named herein that a Memorandum of Understanding be formalized based on the headings set out below:

- 1. Parties to the Understanding
- 1.1 MONO-CENTER FOR PROVISION OF SERVICES TO THE UNEMPLOYED POPULATION "ISHGA MARKHAMAT" UNDER THE MINISTRY OF EMPLOYMENT AND LABOR RELATIONS, Uzbekistan The Republic of Uzbekistan.
- 1.2 NANJING POLYTECHNIC INSTITUTE, The People's Republic of China.
- 2. Statement of Purpose
- 2.1 The two Parties recognize that they have many interests in common and that there will be mutual benefits from collaboration and co-operation.
- 2.2 The two Parties wish to formalize and standardize the relationship between the two parties in order to provide consistency, and a focal point, for the preparation and administration of programs for collaboration and co-operation.
- 2.3 This Memorandum provides the mechanism through which the expressed intent of the parties can be realized.
- 3. Objectives
- 3.1 The Subject Areas

The subject areas for the potential collaboration and co-operation have been identified as, but not limited to, the following activities:

- International students program
- Exchange of existing staff
- Joint research and teaching activities
- Joint Program
- Participation in seminars and academic meetings

- Exchange of publications, academic materials and other information
- 3.2 Each mutually identified and agreed activity, shall be covered by a separate Agreement which will be an annex to this Memorandum.
- 3.3 The separate Agreements must have the formal approval of the Director of both institutions or their nominees.
- 4. Terms and Conditions of this Memorandum
- 4.1 The term of this Memorandum shall be five (5) years from the date of the last signature. It may be renewed upon each expiry by mutual agreement between the signatories to the Memorandum, or their nominees.
- 4.2 The Memorandum may be revised at any time by mutual agreement between the signatories to the Memorandum, or their nominees.
- 4.3 Either Party may terminate this Memorandum at any time by giving not less than six months' notice in writing. Such action will only be taken after mutual consultation at no less than Director Level.
- 5. Financial Matters Relating to this Memorandum
- 5.1 Unless otherwise agreed in an annex to this Agreement, each Party shall be responsible for its own financial obligations arising from those collaborative and co-operative activities undertaken within the terms of this Memorandum.
- 6. Disclaimer
- 6.1 Nothing shall diminish the full autonomy of either party, nor will any constraints or financial obligations be imposed by either party upon the other in carrying out this Memorandum, unless otherwise agreed in an annex to this Memorandum.
- 6.2 In confirmation of the Purpose of the Agreement reflected in Clause 2 above, this Memorandum reflects the mutual desire and intent of the parties to engage in mutual collaboration and co-operation and outlines the basic framework through which such collaboration and co-operation will occur. It therefore represents a basic understanding between the parties, with specific separate activities identified earlier undertaken only when a relevant annex or annexes to this Memorandum have been agreed.
- 6.3 This MOU is not legally binding on both parties, but both parties will implement this memorandum in good faith.
